On Tuesday, May 6th, my office holding a Hybrid Office Hours event at Hillsborough Library Branch from 11am-2pm. RSVP HERE.


### LGBTQIA+ Know Your Rights Webinar

This week I convened a panel of civil rights experts and LGBTQIA+ advocates for a "Know Your Rights" webinar to educate the public, and especially members of the LGBTQIA+ community, on their rights amid far-reaching attacks on individual liberty by the Trump Administration.

#### **Lead Removal Funding Cuts Conference**

On Wednesday, I participated in a press conference in Trenton hosted by Isles, Inc. a community development group. The conference was held to draw attention to the continued presence of lead pipes in some Trenton housing. We passed funding to remove and replace the outdated and dangerous piping, but the Trump Administration has decimated the federal agencies responsible for facilitating the projects, leaving millions of Americans across the country — and right here in New Jersey — at risk of lead exposure. I'll continue to fight in Washington to make sure these projects can move ahead, and our residents can be assured of their health and safety.
