A BILL

To amend the Internal Revenue Code of 1986 to treat diapers as qualified medical expenses; and to prohibit States and local governments to impose a tax on the retail sale of diapers.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Improving Diaper Af-
- 5 fordability Act of 2025".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:

1	(1) Diapers are an essential need for the health
2	and hygiene of babies and toddlers.
3	(2) Families without adequate access to diapers
4	face a higher risk of poor health outcomes for their
5	children, including diaper rash, severe dermatitis, in-
6	fections, and hospitalization, while also posing a sig-
7	nificant risk to maternal mental health.
8	(3) Families with diaper need lack a sufficient
9	supply of diapers to keep a baby or toddler clean,
10	dry, and healthy.
11	(4) 46 percent of families with children age 4
12	or below struggle to provide the diapers their chil-
13	dren need; this is an increase from 1 in 3 families
14	expressing diaper need before the COVID-19 pan-
15	demic.
16	(5) Low income families make up 2 out of 3
17	families with diaper need; a disproportionate amount
18	of these families are Black or Latino.
19	(6) Annually, families spend between \$945 and
20	\$1,500 on diapers for a child under age 4; a low-
21	income family of 4 spends 2.6 times more of their
22	income on diaper costs compared to a family of 4
23	making median income.
24	(7) Diaper need affects not only the health and
25	well-being of the child but it can affect the economic

1	security of the entire family, forcing families with di-
2	aper need to cut back on food purchases and per-
3	sonal savings.
4	(8) 25 percent of parents and caregivers with
5	diaper need reported having to miss work or school
6	because they did not have enough diapers to drop
7	their child off at childcare, and reported missing, on
8	average, 5.1 workdays in the past 30 days; this rep-
9	resents a loss of \$296 per month for a parent earn-
10	ing the Federal minimum wage of \$7.25 per hour.
11	(9) No permanent State or Federal child safety-
12	net program allocates dollars specifically for the pur-
13	chase of diapers.
