This week in Washington has been one of continued chaos. House Republicans pushed through a **funding bill** that handed over Congress' power of the purse to the executive branch, diverting taxpayer dollars to a slush fund for Trump and Musk to access with no oversight. Rather than engaging in responsible governance, Republicans have chosen to cede authority and leave critical programs - like veterans' healthcare, public health initiatives, and support for small businesses - at the mercy of a corrupt partisan administration. Meanwhile, GOP dysfunction makes it clear that their priorities lie with billionaires and not the American people.

My Vote Against the Republican Funding Bill that Cuts Services

This week, I voted against the GOP's funding resolution that amounts to an unregulated slush fund for President Trump and Elon Musk. It cuts veterans benefits, it cuts housing, and it puts Social Security, Medicare, and Medicaid at risk.

This vote was about handing over even more power from the people's representatives to President Trump. It absolves Congressional Republicans of the responsibility of governing. It tells Donald Trump, 'Do whatever you feel is right, the needs of my constituents be damned.' It is truly a pathetic yielding of power from Congress to the President.
