### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Public Housing Fire

5 Safety Act".

### 6 SEC. 2. DEFINITIONS.

#### 1 SEC. 3. INSPECTIONS OF PUBLIC HOUSING.

2 (a) IN GENERAL.—With respect to inspections of
3 public housing conducted by the Secretary, including
4 through the Real Estate Assessment Center, the Secretary
5 shall report on the presence or absence of automatic sprin6 kler systems in the public housing.

7 (b) REPORT.—Not later than 3 years after the date of enactment of this Act, the Secretary shall, based on 8 9 inspections of public housing conducted during the 3-year period beginning on the date of enactment of this Act, sub-10 11 mit to Congress a report on the presence or absence of automatic sprinkler systems in public housing, in par-12 13 ticular in exempted public housing projects, which shall include recommendations to improve fire safety in exempt-14 ed public housing projects. 15

(c) RULE OF CONSTRUCTION.—Nothing in this section shall be construed to require a public housing agency
to install an automatic sprinkler system in an exempted
public housing project.

# 20 SEC. 4. GRANT PROGRAM TO RETROFIT PUBLIC HOUSING

#### WITH AUTOMATIC SPRINKLER SYSTEMS.

(a) ESTABLISHMENT.—The Secretary shall establish
a competitive grant program under which the Secretary
shall award grants to public housing agencies to install
automatic sprinkler systems in exempted public housing
projects.

(b) LIMITATION.—A public housing agency may not
 use amounts received under this section to install auto matic sprinkler systems in a rebuilt multifamily property,
 as defined in section 31(c)(2)(B)(iii) of the Federal Fire
 Prevention and Control Act of 1974 (15 U.S.C.
 2227(c)(2)(B)(iii)).

7 (c) AUTHORIZATION OF APPROPRIATIONS.—In addi8 tion to amounts appropriated to the Capital Fund under
9 any other provision of law, there is authorized to be appro10 priated to the Capital Fund \$25,000,000 for each of fiscal
11 years 2024 through 2033 to carry out this section.
